## LOUISVILLE VELO CLUB RIDER AGREEMENT

1. Members are "required to volunteer" the day of our Louisville Velo Club race/event. The 2018 event is TBD.
2. Memberships will expire and be renewed at the LVC Annual Meeting.
3. Members agree to purchase a current team kit.
4. Members are encouraged to participate and assume a leadership role in the weekly rides. (There are rides to accommodate all paces) See the Louisville Cyclery website club section for a detailed ride schedule.
5. Members will present a "public face" for LVC, Louisville Cyclery LLC, and supporting sponsors through participation in organized cycling events.
6. Members will wear the team kit on club rides and at events. Your kit must represent current sponsors.
7. Members must register at all races under the "Louisville Cyclery" designation.
8. You are representing Louisville Cyclery and your sponsors whenever you are on your bike. Discourtesies or violations reported concerning traffic, spectators, officials, other cyclists or any other individuals may be cause for forfeiture of your membership.
9. Louisville Cyclery will provide members in good standing with discounted merchandise (some exceptions apply). New bicycles, frames, groups, and special-order items are subject to different terms, and discussed only on a "face-to-face" basis.

# Louisville Velo Club - League of American Bicyclists Waiver

## **RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT ("Agreement") for**

### **LOUISVILLE VELO CLUB and LEAGUE OF AMERICAN WHEELMAN d/b/a LEAGUE OF AMERICAN BICYCLISTS ("LAB")**

IN CONSIDERATION of being permitted to participate in any way in "Louisville Velo Club" ("LVC") sponsored Bicycling Activities ("Rides") I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of Bicycling Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further acknowledge that the Activity will be conducted over public roads and facilities open to the public during the Activity and upon which the hazards of traveling are to be expected. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2. FULLY UNDERSTAND that: (a) BICYCLING ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the Activity, the conditions in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Activity.

3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE the "LVC", the "LAB", Louisville Cyclery LLC, their respective owners, administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim.

4. ACKNOWLEDGE by signing this waiver that I am a member of the "Louisville Velo Club", or if not, will be automatically enrolled as a "Louisville Velo Club Member" ("by signing").

I AM 18 YEARS OF AGE OR OLDER, HAVE READ AND UNDERSTAND THE TERMS OF THIS AGREEMENT, UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS BY SIGNING THIS AGREEMENT, HAVE SIGNED IT VOLUNTARILY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW. I AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
